## AUTHORISATION UNDER BIO MEDICAL WASTE (MANAGEMENT & HANDLING) RULES, 1998 - AS AMENDED TO DATE

### FORM IV

(Authorization for operating a facility for Collection, Reception, Treatment, Storage, Transport and Disposal of Bio-Medical Wastes.)

1. **MEDICAL SUPERINTENDENT** of **DR. HEDGEWAR AROGYA SANSTHAN** is hereby granted an authorization to operate a facility for generation, collection and storage of biomedical waste at the premises of **F-18, Karkardooma New Delhi - 110032** and for transport, treatment and disposal of bio-medical waste through any of the Common Bio-Medical Waste Treatment Facility (CBWTF) in Delhi authorized by Delhi Pollution Control Committee.
2. This authorization shall be in force for a period of **3 Years** from the date of application and shall be valid up to **07-05-2016**
3. This authorization is subject to the conditions stated below and to such other conditions as may be specified in the Rules for the time being in force under the Environment (Protection) Act, 1986.

### Terms and conditions of authorization

1. The occupier shall comply with the provisions of the Environment (Protection) Act, 1986 and the rules made there under.
2. The occupier shall comply with the provisions of Bio-Medical Waste (Management & Handling) Rules, 1998, as amended to date.
3. Effluent Treatment Plant(ETP) installed, shall be properly operated and maintained and the treated effluent shall be recycled / reused in horticulture, air conditioning / cooling plants and in flushing of toilet etc. The occupier will comply with the standards prescribed in Schedule V of BMW Rules, for the discharge of the Waste Water / Effluent generated from the hospital and submit the Effluent Analysis Report, both for inlet (untreated) & outlet (treated) effluent of ETP for the parameters prescribed for liquid waste in Schedule V of said BMW Rules from any of the Empanelled Laboratories of Delhi Pollution Control Committee (DPCC) on quarterly basis to DPCC.
4. The authorization or its renewal shall be produced for inspection at the request of an officer authorized by DPCC.
5. The person authorized shall not rent, lend, sell, transfer or otherwise transport the bio-medical waste without obtaining prior permission of DPCC.
6. Any unauthorized change in personnel, equipments or working conditions as mentioned in the application by the person authorized shall constitute a breach of this authorization.
7. It shall be ensured that the Bio Medical Waste is finally treated within a period of 48 hours. If for any reason it becomes unavoidable, intimation should be given in writing to DPCC and measures are to be ensured so that the waste does not adversely affect human health and the environment.
8. It is the duty of the authorized person to intimate DPCC immediately in case of closure of the facility/unit.
9. The occupier shall have a valid agreement with the operator of a Common Bio-Medical Waste Treatment Facility (CBWTF) authorized by DPCC for collection, transportation, treatment & disposal of the bio-medical wastes in Delhi. Further, the occupier shall also submit the copy of fresh valid agreement to DPCC within 15 days prior to the date of expiry of previous agreement or in case of any change of agreement with the operator.
10. The occupier shall ensure that bio-medical waste shall not be mixed with other wastes and shall be segregated into containers / bags at the point of generation in accordance with Schedule-II and the bio-medical waste handed over to transporter / operator of a CBWTF shall be duly segregated, labeled, tagged and kept in proper containers for the transportation as per rule.
11. The occupier shall use Sharp Boxes for the collection of the sharps at the source of the generation

of the sharps for proper sharp management.

12. The occupier shall also ensure proper collection and disposal of bio-medical waste containing mercury. The occupier shall also phase out mercury based equipments e.g. thermometers and O.P. Measuring Equipments.

13. The Bio-Medical plastic wastes shall be disposed off only after proper chemical disinfection / autoclaving / micro waving followed by shredding / mutilation to prevent unauthorized reuse or through Common Bio-Medical Waste Treatment Facility (CBWTF).

14. The occupier shall maintain records of the Bio-Medical Waste generated and disposed off/ handled on daily basis. The record shall be made available for inspection & verification to any officer authorized by DPCC.

15. The occupier shall submit the Annual Report in Form-II by 31st January every year, including information about the categories and quantities of bio-medical waste generated during January to December of preceding year.

16. The occupier shall not handle the Bio-Medical Waste from any other health care institution without obtaining prior permission from DPCC for Operator of a facility failing which the occupier shall be liable for legal action for illegal handling of the bio-medical waste.

17. In case of failure to comply with any of the above conditions and / or with any provision of the Act or of these Rules, authorization issued to the Occupier may be suspended or cancelled as per the provisions under sub-rule 7 (8) of Bio-Medical Waste (Management & Handling) Rules, 1998, as amended to Date.

18. In case of any accident involving Bio-Medical Waste, the occupier shall report the accident in Form-III, prescribed under the Rules, to DPCC.

19. Submission of false information shall be liable for cancellation of the authorization without notice.

20. The occupier shall apply for renewal of authorization under the aforementioned Rules before one month of the expiry of the authorization.

21. In case the occupier is having a DG Set, he shall comply with the noise standards laid down vide Gazette Notification of Ministry of Environment and Forest(MOEF), Government of India Dated 17.05.2002 and 12.07.2004, as amended to date, for the Diesel Generator Set(s). Stack height with the DG Set shall be as per the following formula,  $H$  is equal to  $h$  plus  $(0.2 \times \text{square root of KVA})$  where  $H$  is Total Height of stack in meter,  $h$  is Height of the building in meters where the Generator Set is installed and KVA is Total Generator capacity of the set in KVA). The occupier shall also submit a latest noise monitoring report (not older than 6 months) of DG Set from any of the empanelled laboratories of DPCC within 6 months from the date of issue of the authorisation, if not already done.

Please note that the issuance of authorization shall not be construed in any manner whatsoever that you are legitimately operating you health care institution with respect to other statutory requirements viz-local land use, Master Plan of Delhi etc.

This issues as per the recommendations/decisions of BMW Committee No. 1 in the meeting held on 03.02.2014.
