The Miscellaneous Application No. 582 of 2015 filed before the Tribunal. Let Registry, register and number the same as per law.

This Application seeks recall of our order dated 18<sup>th</sup> May, 2015 whereby Application No. 284 of 2015 was dismissed for default of appearance. For the reasons stated therein, we recall order dated 18<sup>th</sup> May, 2015 to the extent that M.A. No. 284 of 2015 stands restored as to its original number.

With the above terms M.A. No. 582 of 2015 disposed of.

Notice to all the counsel appearing in this case. Copy be furnished during the course of the day.

The Learned Additional Solicitor General appearing for various Ministries submits that she has to file certain additional documents. Liberty is granted. Let the documents be filed within three weeks from today.

A short affidavit on behalf of Government of India is sought to be filed. Liberty granted and the same be filed within three weeks from today.

In the meanwhile NCT, Delhi as well as Government of India would file reply as to why the Tribunal should not pass appropriate orders in accordance with law for non-compliance of its earlier direction. Let that be done within three weeks from today.

The Learned Additional Solicitor General would get clear instructions as to why in furtherance to our direction Container corporation of India be not directed to be shifted outside Delhi from its present location at Tuglakabad. The six axle trailer/heavey vehicles, which bring heavy cargo cause serious pollution as well as congestion in



entire Delhi and hence add to pollution. Why they be not required to diversify the same to the site which have already been identified or the site which would be identified if necessary.

List this matter for hearing on 13<sup>th</sup> to 15<sup>th</sup> July, 2015 at the end of the board.

Reply M.A. No. 482 of 2015 be filed within three weeks from today. We notice Non-compliance more particularly in relation to establishment of check posts and weigh bridges at all entry point at Delhi.

We also grant liberty to CPCB to file additional data and report in support of its report already filed. All interim orders will continue to in force till then.
