# I. Garbage Disposal around Dwarka Area

## ACTION POINTS

- MCD was instructed to keep the area clean in order to avoid penetration of birds in the area.
- Delhi Waste Management Company to clear garbage twice a day in the Dwarka Sectors 8, 22, 23 & 24.

## Status

- As per MCD's letter, directions are being complied.

## II. Water Stagnation around IGI Airport

### ACTION POINT

- Wastewater from Mahipalpur area – DJB.

### Status

- DJB has awarded the project of laying of sewer lines in Mahipalpur, Rangpuri, Smalkhan, Rajaukri and Kapasheda on 1<sup>st</sup> July 2008.
- Time period of completion is 2 years.
- CM laid foundation stone on 07.09.2008.
- Execution will be started after monsoon.
- Construction of 4 MGD STP at Kapasheda is a separate project. Tendering done.

## II. Water Stagnation around IGI Airport

### ACTION POINT

- DDA officials shall make a visit in the water stagnation area of Dwarka sector 20, 22 and Bagdola and submit an action taken report.

### Status

DDA to respond.

# III. Illegal Meat Selling in Dwarka and Indra Market – R K Puram

## ACTION POINT

- 60 nos. of illegal meat/poultry shops are operating in the area. Delhi Police to close down the illegal meat/poultry – Delhi Police.

## Status

As per data provided by police:

- Around 15 shops have been removed.
- Around 10 shops have changed their trade.
- Rest will be removed by ....(Delhi Police to respond).
- Legal action initiated against violators. 1 case u/s 424 DMC Act has been registered and 3 persons under section 93/97 DP Act, 19 persons u/s 65 DP Act and 2 vehicles have been deposited u/s 66 DP Act.

## **IV. Piggery in Mehramnagar and Mahipalpur**

### **ACTION POINT**

- DCB and MCD to remove piggeries.

### **Status**

- The unauthorized meat selling shops at village East Mehram Nagar have already been closed by DCB. Strict Vigil is being exercised to prohibit any un authorized slaughtering / dumping of meat in Cantonment area.
- Owners of pigs at Mahipalpur have been prosecuted by MCD on 03.09.2008.

## **V. Make Shift fish and poultry stalls in Cantonment area - DCB**

### **ACTION POINT**

- Cantonment Officials and Police to take action against such law breakers.

### **Status**

- DCB and Police to respond.

## **VI. Animal Waste from Dabri Mode Market - MCD to take Action**

### **ACTION POINT**

- MCD to take action to remove animal waste.

### **Status**

- MCD to respond



## **VII Bird Concentration over Sadar Bazar – MCD to take Action**

### **ACTION POINT**

- Illegal and insufficient slaughter waste disposal outside Civil slaughter house in Sadar Bazar attracting kites.
- Garbage Mountain in Gazipur including slaughter waste attracting over a lakh of Pariah Kites.

### **Status**

MCD to respond.

# VIII Cleaning of drains in Dwarka Zone

## ACTION POINT

- Regular cleaning of drains in Dwarka area.

## Status

DDA to respond.

- Bird radars to be installed.
- Bird shooting to be carried out.
- Vermi-composting practice to be adopted.

- Local incineration of animal waste.
- Proper maintenance of waste dump site.
