





Kindly refer your letter date 5/5/2013 wherein inter-alia this office has been asked to advise the criteria to be adopted in deciding the inter-se seniority of 22 members.

This office has examined the matter. In this regard, it is to be mentioned that dates of applications for membership could not be relied for preparing the inter-se seniority list as the original applications do not seem to be available with the Administrator/Society or this office. Further, the dates of payments of share money/membership receipts are same in 21 of the 22 cases; hence this could also not be a criterion for inter-se seniority. Therefore, this office is of the view that the inter-se seniority has to be determined on the basis of dates of payment (especially first installment) made by members towards construction of flats. Accordingly, and keeping in view the recommendations made in your aforesaid letter, a draft inter-se seniority list for the Maitri Nagar CGHS Ltd. has been prepared, which is annexed herewith. The 22 members in question are placed at Sl. No. 84 to 105 in the enclosed list. Also, the 10 members referred in your letter dated 5/5/13 for expulsion, who have failed to furnish any document in spite of publishing of public notice in newspaper, have been deleted from the inter-se seniority list.

The Administrator is requested to verify the contents and also display the enclosed list on the notice board of the society and then after going through the objections/suggestions, if any raised by the members concerned, forward this office a final inter-se seniority list latest by 22nd July, 2013.

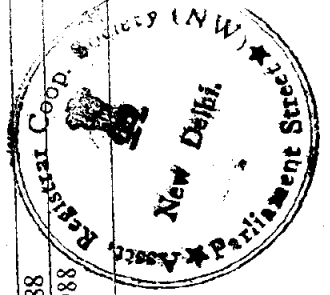


